**Respite Care Program - provides respite funds for the caregiver of a recipient age 60 or over. The recipient must be a resident of Southern Nevada, have a need for 24-hour supervision and reside with the caregiver. Respite can be used for medical reasons, vacation, or any other time needed in order to help reduce the stress level of the caregiver. Over 500 individuals were helped by this program during the year.**

**Transportation Program - provides services for wheelchair bound seniors through the use of fully equipped handicap vehicles, taking them to medical appointments, shopping, etc. Participants must be age 60 or over and require the use of a wheelchair. **Senior Necessities Program - through collaboration with other community organizations, we have established a pantry of non-perishable items and offer a free bag of food and paper goods once a month to help seniors supplement nutritional needs. During the fiscal year, over 900 individuals were helped through this program.**
