Our Senior Social program provides seniors with nutritious meals in a friendly, community setting. This program not only ensures access to healthy food but also fosters social interaction and a sense of belonging. By bringing seniors together for regular meals, we combat isolation and promote overall well-being within the senior community of Southern Nevada.

## Program Details

- Services are provided at no cost to eligible clients.
- Two locations are available; please refer to the website for addresses.

## Eligibility

- Applicants must provide proof of Nevada State ID.
- Proof of age is required.
- Completion of the Registration Form

## Client Requirements


- Pantry services are exclusively offered to approved and evaluated clients aged 60 or above.
- Clients need to furnish evidence of Nevada residency.

## Program Rules


- Eligible clients can avail themselves of one complimentary meal per day at either location, up to 5 days a week.
- Guests aged 18 and above are welcome at a charge of \$4.
- Leftover food is not available for purchase.
- Clients must consume at least 50% of the meal on-site.

- Accommodate 20 frozen meals
- Ability to heat meals
- Not enrolled in Meals on Wheels

- Must be able to pick-up meals from designated community pick-up points
