- Eligibility also requires an income at or below 185% of the Federal Poverty Level.
- Residency in Clark County, Nevada, is a prerequisite.
- Completion of the Registration Form

## **Registration Process**

- Pantry services are exclusively accessible to approved clients aged 60 or older following assessment.
- Clients must finish proof of Nevada residency and complete an income declaration.

### **Client Requirements**

 Registered clients are permitted to visit the pantry once a month on Mondays through Wednesdays from 8 am to 12 pm.

\*\* In cases where eligibility is not met or additional food assistance is needed within the month, clients may request an emergency food bag.
